Priority Areas Adopted by the Full OCTF as of January 10, 2025

1) Employment

- a. Support the Work Without Worry Act
 - i) A bill to create a "Work without Worry" program in Iowa Medicaid was discussed by lawmakers last year and advocates are asking for its passage this year. It would remove the penalties for a working spouse's income and raise he income and asset limits for Medicaid coverage for Iowans with disabilities.
 - ii) Bill History: Committee approval 2/19/24. Introduced and referred to appropriations
 - iii) Currently in draft form and will again be proposed by Rep. Josh Turek.
 - iv) Modeled after the bill that passed in Tennessee.

2) Medicaid

- a. Overhaul at state level; reauthorization at federal level
- b. A new <u>CBPP brief</u> reports that per capita caps are in discussion again. Iowa expenditures have exceeded the proposed cap in at least 4 years: by 7% in 2019, 8% in 2020, 3% in 2021, and 11% in 2022 which could mean drastic cuts.
- c. Track reforms (past and future) and have a presence at public comment meetings
- d. Iowa
 - i) A budget increase is proposed for this year (HF 13) CAN ADVOCATE NOW
 - ii) Most of that will go towards rate increases for providers
 - iii) ICAP continues to lead that charge
 - iv) Long-term could sustain current service and potentially increase services
 - v) Threatened by what happens at the federal level

e. Federal

- i) Per Capita Caps discussions are ongoing CAN ADVOCATE NOW
- ii) Many efforts aimed at impact of caps at both the local and federal level
- iii) IDDC sponsoring a webinar next Friday at noon as a general education session (sign up to receive alerts)

3) Availability of Services/Capacity

- a. Waiting lists and inadequate number of providers to meet the need
- b. Inadequate reimbursement rates for providers

- **February 14**: Final day for legislators to request bills (committee chairs may still request study bills after this date).
- March 7: First deadline (called a "funnel"). Bills must be voted out of committee by this date (except for tax and budget bills).
- April 4: Second "funnel" deadline. Bills must be voted out of committee in the second chamber (so House bills out of Senate committees and Senate bills out of House committees).
- May 2: 110th day of session (the "last day" legislators lose staff and "per diem" expenses).
